NOTICE is given that Cambridgeshire County Council has made an Order pursuant to the Road Traffic Regulation Act 1984, as amended by the Road Traffic (Temporary Restrictions) Act 1991, the effect of which is to stop any pedestrian from proceeding along Sutton (Ely) Footpaths 7, 9 and 16, Sutton; Footpath 5, Mepal; and Downham Footpath 24, Little Downham as lies between Chatteris Footpath 7 and Earith Footpath 9; Haddenham Footpath 24 and Mepal Footpath 7; Sutton (Ely) Footpath 8 and Sutton (Ely) Footpath 7; and Manea Footpath11 and Manea Footpath 10 respectively.

Access will be maintained to properties affected by this order.

The alternative route for pedestrians will be as signed.

The Order is made to facilitate The Ouse Washes Middle Level Barrier Bank Improvement Scheme and associated works which are being carried out on or near this highway and it will come into operation on 1 June 2021 and continue until these works have finished or on the 31 October 2022 whichever is the earlier.

It is anticipated that these works will be carried out between 1 June 2021 and 31 October 2022.

The Order shall not apply to any persons lawfully engaged in connection with any works for which it is made, any member of the Police Force, Fire and Rescue Service, Ambulance Service, a vehicle being used by Special Forces during the execution of their duties or to any person acting with the permission or upon the direction of a Police Officer in uniform.
