It was proposed by Mr Browne, seconded by Mr Jordan **and resolved unanimously to recommend outright refusal of the application. Sutton Parish Council acknowledges the letter from the resident at 10 Oates lane and shares continued support of the objections already given and those of other residents. The stance of the council has not changed, there is still a clear violation of the Sutton Neighbourhood Plan and ECDC planning policies, Drainage is still a cause for concern and Sutton Parish Council s concerns have not bee addressed from previous applications.**
