Update:

Health provision in Sutton – Priorsfield Doctors Surgery Closure – 31st March 2023

- A petition has been launched online with over 1800 signature so far in support of saving the surgery.
- Cambridgeshire and Peterborough Integrated Care System (ICS) has been contacted and pressing them to assist residents.
- Fenland Practice announced to ICS that they would not be renewing their contract that ends on the 31st March.
- ICS tried to find a new practice to take on the contract and attract other GPs to join the practice to no avail
- ICS started the process of a Managed list dispersal for 5959 patients registered to Priorsfield surgery to other practices.
- A total of 10 other sites have agreed to take on patients and this process starts 7th March
- Allocation will be based on Post codes per family
- No transfers will be looked at until after 1st April to allow for the new surgeries to update systems
- Fenland practice are a private business and the building is privately owned
- Lorna Dupre and Mark Inskip met with Clinical Chief of the ICS and public meetings will be held for patients to attend Tuesday 7th March and 8th March. An evening session is being looked at.
- Attendees will be asked what they want and need as a Primary care service in the village.
- Cllr Dupre has written to MP Steve Barclay and has had no response to date.

- There are concerns with patients not being able to get to their new allocated surgeries with limited public transport in the village and to the potential new practices.
- Unsure how repeat prescriptions will be possible, this is to be researched
- Fenland Practice comprises of 4 sites, Doddington, Wimblington, Manea and Ramsey. The Priorsfield site is a separate contract, this is why Sutton is not being renewed

186/23 School Holiday Clubs

1. To receive report from Clerk on proposed clubs

The Clerk has met with the Area Manager and Director Premier Education East Cambs & West Norfolk, with a view to them offering school holiday sports club provision for Summer 2023.

They also have Easter sessions identified, but HAF have just been let down with a venue in Chatteris, and the County Council has agreed to transfer the funding to 4 days in the Easter holidays to Sutton. Premier Education can in addition to this accommodate a further 20 children, these places will have to be paid for by a fee to the parents.

For August, Premier Education and the County Council can also provide the HAF program, and also open this to other children on a primary school age in the village. This can either be funded by them a fee to the parents, or the parish council can apply for grant funding, if this is granted the sessions can be run free to all children.

187/23 Request from Sutton Conservation Society

1. Request from Sutton Conservation Society

Members of the conservation society have been clearing nettles and brambles from the back of the Orchards in the Paddock. They have a few requests.

- They would like the grass cutters to cut this area during the summer to stop the nettles and brambles growing back.
- ii) Willow Arch They would like to grow a Somerset willow arch around the existing bench in the orchards in memory of the Late Liz Rhodes and will secure a plaque
- iii) They would like to plant daffodils, snow drops and aconites along the ditch at the back of the Orchards. (The grass around the trees would need to be cut in early October so the daffodils can be planted later on that month)
- iv) Funding is being sought for the help in purchasing the bulbs and the willow.
- 2. To receive information from the clerk on current contract for The Paddock.

The current contractor cuts the grass up to the edge of the brambles and the Village Lengthsman also attends the site and cuts back areas when necessary, within their capabilities.

3. Council to consider request.

It was proposed by Mr Browne, seconded by Mr Inskip and resolved unanimously to look at the options for point i) with the village Lengthsman and contractor, Councillors will visit the site to look at the area involved. Point ii) was approved to allow a Somerset Willow Arch to be built around the existing bench and for the Conservation society to apply for a grant through the Parish council for any funding requests for bulbs and willow.

188/23 Provision of Planters for the village

1. To consider types of planters and locations

The open spaces group and the councils Sports and Recreation working party have looked at placing planters around the village to make it more colourful.

Suggested locations – Village Sign (Ely Road), Village sign (Chain Causeway), Under notice board on High Street and Recycling centre area on The Brook/Junction Pound lane.

The area under the village sign was discussed and agreed that this is not a suitable location. Additional locations and funding will be looked at by the sports and recreation working party.

It was proposed by Mr Newton, seconded by Mr Goodjohn and resolved unanimously to approve that a suitable sized low maintenance, self-watering reservoir, plastic planter be purchased and permissions sought from the county council to have it placed at the Village entrance sign on Ely Road.

The application by Sutton Feast Committee is to have a section of the High Street closed between Lawn Lane and Stewards Close from 9am to 7pm on Sunday the 7th May for a Coronation street party for the village has been received. The Parish Council had no comments to make about the road closure application and will request further information from the committee regarding the plan for the event, so that the office has the details.

190/23 Warm Hubs

1. To receive an update from the clerk on the warm hub.

The Sutton Warm hub opened on the 16th November and has been open every Wednesday from 9am to 12pm since then (Excluding 28th December when it did not open). We have had 5 volunteers who have helped to run the Warm hub throughout the time it has been open.

However, the warm hub has had a total of 4 attendees between 16th November and 22nd February, The council has advertised the warm hub on social media, placed posters in all facilities, local shops and on village noticeboards.

Sutton Timebank volunteers are not available during March to run the Warm Hub.
