# 208/23 Burial Ground Fee and charging structure review.

1. To receive report from the Deputy Clerk

Sutton Parish Council last reviewed the Burial ground fees in 2021 and increased the fees from 1st April 2022. When reviewing other parishes fees for Burials and Ashes Interments and after speaking to several Funeral Directors, the council has a different pricing structure to other burial authorities and the current fees are lower.
