# 44/23 Parking issues and disability parking outside One-Stop.

### 1. To receive report

A disabled resident has raised concerns over the lack of parking at the One Stop Shop. He is unhappy that the parking restrictions are not being adhered to and cars are parking in the short stay spaces, meaning it is hard for him and other residents with disabilities to park outside the shop.

A Disabled parking bay can be applied for through CCC and funded by them if they have funds in their budget. If there is not, the council can pay for the disabled parking bay.
