1. Cllr Lorna Dupre – Cambridgeshire County Council

Cllr Lorna Dupre mentioned expected balance budget in February. Two awards won, Membership Club for staff development and Heat Scheme.

Post office: Much clearer statement. One Stop will be offering a drop to collect, bill payment and pre-paid parcel service – no banking or over counter services. The Post Office service could be re-located but worried this would reduce the foot fall for One Stop.

GP Surgery – Lorna met with NHS Cambridge and PPG are putting options together and will hear the outcome in the new year.

Fire Station: Fire Service and fire authority meets 20<sup>th</sup> December to propose to close three fire stations Manea, Kimbolton and Sutton, followed by a period of in-person and online public engagements (up to June 2024). They plan to close 1/1/2025. It was discussed the current issues of staffing, recruitment difficulties and Sutton pump was only used 33 times out of 77 incidents and 40 were serious incidents. It was asked for clear information and evidence that if the Sutton Fire Station closes how quick would the response time be to the area?

**144/23 Draft Budget and Precept 2024/2025**

1. To receive draft budget and information relating to the Precept.

The RFO circulated the draft budget and information relating to the 2024/25 budget.

2. To receive additional information from the RFO

The RFO presented the Staff salary report, EMR and CIL report and the first draft of the 2024/2025 budget.

**Staff Salary Report:** The National Joint Council for Local Government Services (NJC) has reached an agreement for the 1<sup>st</sup> April 2023. All staff will have their pay backdated to this date, and the budget reflects these changes.

**CIL/EMR:** CIL – It is anticipated that a further sum of £29,380 will be spent from CIL funds before 31<sup>st</sup> March 2023.

**EMR:** Timebank has a healthy budget of £4077 (at 31.10.23), and £5924.00 grant funds are held to pay for the 2 weeks sports project before 31<sup>st</sup> March 2023.

**Draft Budget:** Amendments to draft: 2023/2034 (current year) Add £3,500.00 for speed surveys.

**2024/2025 Minor grants scheme,** increase to £2,500.

**Precept:** The working party recommends a 4% increase on Band D to £132.68 (approx.), and a Precept of £192,426.00.

**General Reserve Balance:** The balance on 1<sup>st</sup> April 2023 was £55,881.00, and it is anticipated that the balance on 31<sup>st</sup> March 2023 will be approximately £58,599.00. This will be considered and approved at the budget and precept setting meeting in January.


